1. Sweepstakes Administration

2. How to enter

No purchase is necessary to enter. To enter without earning an automatic entry, email your name, address, and phone number to marketing@unitusccu.com no later than 12:00 p.m. on February 7, 2026 – email entries will be placed in the \$500 Walmart Gift Card drawing only. Odds of winning depend on the number of entries received.

Receive one (1) entry for attending the Grand Opening event, one (1) entry for following on social media and one (1) entry for being a Unitus member. Up to three (3) entries are allowed per person. Entries are placed in the prize bucket as selected by the person entering the drawing(s).

3. Sweepstakes Period

The Sweepstakes period runs between 11:00 a.m. and 1:45 p.m. on February 7, 2026. The winners will be drawn during the Woodburn Grand Opening event; the first round of winners will be drawn at 12:30 p.m. and the final round at 1:45 p.m. on February 7th and all winners must be present to win.
