

## **'Virtual Branch Grand Opening BINGO' Sweepstakes Rules**

### **1. Sweepstakes Administration**

This sweepstakes is being administered and operated by Unitus Community Credit Union (Unitus).

### **2. How to enter**

Participants may enter the sweepstakes by completing three-in-a-row in any direction on their Unitus Virtual Branch Grand Opening BINGO card to be submitted in online form accessible from Virtual Branch Grand Opening landing page. Follow the prompts in each square and reference the landing page for FAQs for additional guidance. Extra entry allowed per person for completing all nine-squares (blackout BINGO card). No purchase necessary to enter.

### **3. Sweepstakes Period**

The Sweepstakes period runs from 12:00 a.m. on October 27, 2020 to 11:59 p.m. on October 31, 2020. One winner will be randomly selected from all eligible entries and will be contacted no later than November 6, 2020. In the event we are unable to contact the winner by phone or email, Unitus CCU will choose an alternate winner two (2) business days after the applicable Drawing Date.

### **4. Eligibility**

The prize will be awarded by random drawing of all eligible entries. Odds of winning depend on the number of entries received. To be eligible for this drawing you must be a natural born person, lawful permanent resident of the United States, 18 years of age or older. Void where prohibited by law. Employees of Unitus CCU and their immediate family members are not eligible to participate. All decisions are final and are at Unitus CCU's sole discretion.

### **5. Prize**

Winner will receive an Oculus Quest 2 (64 GB) valued at \$299. Prize will be shipped to address specified by winner via phone or email. The prize will be awarded by random drawing of all eligible entries. You do not need to be a Unitus member in order to be deemed eligible.

The prize that may be awarded to the eligible winner is not transferable or exchangeable for any other prize. If a winner cannot be contacted or is disqualified for any reason, Unitus reserves the right to determine an alternate winner or not to award that winner's prize, in its sole discretion.

All decisions are final and binding. Unitus shall not be responsible for late, lost, misdirected, or unsuccessful efforts to notify winner.

### **6. General Conditions**
